# 4. Business Arising from the minutes

# a. Professional Development Funds

At the last Success By 6 meeting, our steering committee was told that it's possible to use Professional Development funds for parent development.

### b. Circle of Security - Guests Mary Ives, Bev Stobbe

Bev and Mary have both been trained in the Circle of Security parent education program. Based on their knowledge of both Circle of Security and Triple P, they feel that there needs to be a very good child-adult connection in order for Triple P to be effective, and that Circle of Security is a very good option for parent workshops.

Circle of Security is an eight week course. Although the focus group is the earlier years, it continues to apply throughout a person's life. It's designed at grade 4 literacy level.

Cost to sponsor a course: \$800 for one facilitator, \$1,000 for two facilitators. The ideal class size is 8-12 participants; up to 15 is possible. Sessions are interactive, with 1.5-2 hrs each session.

Mary and Bev mentioned the Chilliwack Effective Parenting Committee is in existence; it is primarily about supporting facilitators and networking. The Early Years table might be a good connection for both groups.

**ACTION:** Karen will add Mary to the Early Years committee distribution list. Mary will invite the Chilliwack Effective Parenting Committee to join the Early Years committee. Karen will talk to Debbie and Shannon about arrangements for room use and childcare.

**IDEAS:** Offer the workshops twice, covering the downtown Chilliwack area and Sardis area. If workshops were offered in joint partnership with the School District, there might not be a charge to rent a school facility for the workshops.

#### c. Non-violent Communication on Chilliwack's Children

It is a powerful program which was created by Marshall Rosenburg; William Klassen in Chilliwack offers a workshop. There is a lot of free information on the internet.

**ACTION:** Karen will talk to William about presenting.

**Chilliwack Youth Health Centre** – Traffic at the Sto:lo site has been slow this past year. Patients don't have to be Aboriginal to access that location. It's a beautiful site, with a lot of resources. Please include this information in your newsletters to families.

There will soon be conversation about whether they see themselves as a Health Centre, or a Youth Centre which offers employability, physical health and nutrition, etc. They are currently one of three sites nationally which provide comprehensive mental health services, and have a pediatrician on site. Recently joined is a physician trained in access for Gender for Me care. Patients under 26 years old will be able to access assessments and treatment at the Youth Health Centre, rather than having to leave the community for it.
