1. Welcome and Introductions

Kiran showcased the new Calm Alert program, which is based on Stewart Shanker book "Calm, Alert and Learning: Classroom Strategies for Self-Regulation". This is based on research from Kiran's masters project. There's curriculum training and a module book. The program is modified for preschool and Kindergarten level. It goes through the five areas of self-regulation. Uses stuffed animals, puppets, songs. Books used are geared to 3-6 year olds. One of the purposes is for children learn collectively about emotions, what it looks like when they're happy, and building empathy. When an example of a conflict situation is given, research indicates that boys come from a right/wrong perspective and girls come from a collaborative approach of resolving a situation together. Also teaches self-regulation of personal domains. Dramatic play is encouraged involving role playing including complying with the rules of the roles.



Pilot locations are Central Elementary School, Watson Elementary's Kindergarten class(es), a Chilliwack group daycare.

Kiran will complete a 2 week self-regulation course at UBC in the summer, will obtain feedback from all pilot participants in the Fraser Valley, then will relaunch the program in the summer.

Canadian Tire Jumpstart day is May 25th. CCRR will be involved this year.

- # 5 & 6 Completed the evaluation last year. Not sure that the results have been followed up.
- # 7 Methods of allocating or reallocating funds Process has changed for groups where those which have traditionally received funding from Early Years no longer have to reapply each year.

Other success is the change in Community Coordinators role. Could also be under 4th bullet.

- #8 There is no question 8.
- #9 There are funding challenges.
- # 10 This sub-committee would like to create more community awareness.
- # 13 Number of volunteers at Early Years table and projects (Healthy Kids Day, National Kids Day, etc). At events the Early Years table has participated in there hasn't been an increase in volunteers. City Life has been a good volunteer source.

- # 15 Recommend this be answered from the viewpoint of the programs that you and your agency deliver, rather than the entire table.

Families in Motion has quite a few Aboriginal families attending (bullet 3). Aboriginal



programs run through Central Gateway for Families are strategizing how they can increase their attendance numbers.

Early Years table participation has increased (bullet 8).
