### 4. Business Arising from the minutes

### d. Circle of Security

#### 5. New Business/Other Business

### a. Early Years Regional Conference

The focus is Kindergarten readiness, initiated by the Province of the Early Years. School Districts and supporting community professionals are meeting to discuss transitions into Kindergarten. The date is November 9, 2017, attendance is by invitation. Registration deadline is October 6<sup>th</sup>.

### b. National Child Day

All organizations serving families and the early years are invited to attend, November 21<sup>st</sup>, 2:00-3:00 pm at City Hall. There will be large game pieces in the foyer, story time, and cake.

# c. Grandparents Raising Grandchildren

Parent Support Services Society of BC is looking for space to run Grandparents Raising Grandchildren. They have a facilitator.

**IDEAS:** VanCity has a community room for free use; also try Sardis Community Church.

## d. Grant Opportunity

There is a Vancouver Foundation grant application opportunity which would look at addressing systemic change in the Early Years Framework. This is building on the discussion at the last Early Years meeting about quality of care provided at daycares which are on school premises (not run by the School District).

Fraser Valley Child Development Centre has offered to spearhead the application process. The application criteria includes increasing high quality early care and learning, and increasing policy and practice in relation to it.

The potential project is to conduct a pilot that shifts priorities in child care and includes an accreditation framework. Centres would collaborate to establish what it looks like. The project/application will include the perceived barriers to implementation.



Early Years committee involvement might be to in some way endorse that the program is accredited by the Early Years committee. The committee could do the accreditation process. There was discussion about how that would occur, and whether there would be any liability involved.

The Early Years committee would benefit from learning about the Quality of Care work that is being done in other provinces.

**DECISION:** FVCDC will liaise with Mark Klassen and Nicole Driscoll, about the grant application.

Discussion on other topics as directly below.

Nicole from FVCDC is in a regional parenting outreach position and moving forward will be participating in establishing values and philosophy of parenting. Her role will be to communicate best practices, parent programs, and share information. The next meeting of the committee is November 1<sup>st</sup>.

The CYC Strategic Planning process has begun.

**DISCUSSION:** Consider reviewing the Early Years Strategic Plan, perhaps in January. Add more measurable actions and outcomes.

**IDEA:** Integrate mental health in activities; highlight how an event or activity addresses mental health specifics.

#### e. Conversation 2018

The Conversation will be held on Friday April 27, 2018. A possible topic is self-care for service providers. The steering Committee meets next week. There is still interest in having a parent/daycare provider event the previous evening.

### 6. Task Group Updates (Review)

- Baby Friendly Initiative meeting in October. Promoting breast feeding; ensuring businesses
  are providing space. Certificate of Intent to become Baby Friendly are available. There are 10
  steps involved in order to receive a certificate. Health has receive a certificate. About 130 for the
  Breastfeeding Challenge, not sure of where that ranks in the world for the vent.

### 7. Agency Updates

**Chilliwack Learning Society** – There are a lot of books for giveaway. If you would like some, perhaps even to give out for Halloween, contact Debbie. Let her know how many and for what ages.

**ACTION:** Karen will notify people through the CYC newsletter.

**Sto:lo Nation**– had their Children's Festival in July, which was very well attended. Kids in the Hall was also well attended, with over 100 children.

Sardis Doorway – Has a long wait list. People can self-refer and agencies can refer. It's for those who have kids who are Kindergarten age or younger. The program is for women who are parenting alone (there might be a partner in the home, but that person isn't co-parenting), is affected by



abuse/addictions, has evidence of mental illness, or has a physical illness. They're hosting Circle of Security for their participants at the moment.

**FVCDC** – Have just celebrated 35 years. Tami from Sto:lo Nation was recipient of one of the awards.

**Fraser Health –** The Public Health Dietitian program is very busy, with staff shortages. Their roles are changing. They take part in the new Public Health Nurse orientation training, but are doing fewer nutrition consultations and ongoing trainings on new nutrition topics. The focus will be on strategic policy work; making the healthy choice the easy choice, for instance healthy food choices. Public Health is changing from inviting clients to come in to see them to moving out of the office and into the community. There is a nurse working with the schools in a Health Food Initiative. Local group of counselors provides post-partum support; fee by donation, Public Health will provide 1-1 support for new mothers experiencing depression. Sheila circulated two flyers for post-partum support.

Flu shot season is upon us.
