- 1. Welcome and Introductions
- 2. Approval of Agenda: approved as circulated
- 3. Approval of Minutes of May 20, 2010: approved as amended

Karin brought the recommendation from Donna Gannon and the Joint Chilliwack Learning Community Early Family Literacy/Social Marketing Task Group as follows: (Joint and Social Marketing was added to approved minutes)

b) Minutes of June 3, 2010 approved as amended

4. Business Arising

- a) November 4 Strategic Planning Day discussion: content and shape of the day
 - Donna asked to add 'Collaborative action group' to the Agenda under Business Arising in regards to the Strategic Planning Day.

- ♦ Donna asked if the idea of inviting community supporters was in response to the recommendation brought forward at the May 20, 2010 meeting that read 'that the Early Years Committee assemble key stakeholders to develop a collaborative action plan for sustaining programs the EY Committee has been supporting and is being asked to again support beyond the Committee's available resources this year.'?
- b) We agreed these two ideas seek to gain support for the Early Years work in Chilliwack, yet the intentions differ:
 - i. Donna identified the purpose of the **collaborative action plan meeting** is to bring together stakeholders with vested interests in Early Years Programs with unsustainable funding and who are funded in part by the Early Years Committee. This work would involve those who have the authority and the mandate to move such a plan forward.
 - ii. The purpose of the **Community Celebration** is to annually celebrate and showcase our accomplishments. We would like to invite the stakeholders we are currently connected with and new potential supporters. We will invite them to brainstorm with us and ask how they would like to be involved.
- c) After a lengthy discussion of the expression and decisions reached at the May meeting (see approved minutes of May, 2010) regarding the 'collaborative action group', the following concerns were expressed:
 - i. agencies and ministries are bound by their current budgets and fundraising policies
 - ii. the creation of an action group from this table is redundant and could create conflicts of interest for some
 - iii. that the work at the Early Years Committee is already done collaboratively and partnerships have been formed in order to work on sustainability for programs
- d) No decision was made in the creation of a 'collaborative action group'.
- e) It was also suggested that the CYC may be the more appropriate body to take the lead on the stakeholders meeting so that the work is done 'to support children and youth' rather than it being seen as the Early Years seeking community support and working against those who work with older children and youth.
 - i. In response to this item, it was suggested that this does not fit into the current CYC strat plan. At this time, this table will not move forward with this suggestion and will not take it to the CYC.

f) Strat Plan

- i. In planning for our 2010 Strategic Planning Day, we do not need to redo our strat plan as the current one is approved to 2013.
- ii. There are pieces of the current strat plan that need to be worked on.

ACTION: The Strategic Planning Task Group will start working on this to bring recommendations forward for October's Early Years meeting.

- iii. Ideas for the Community Celebration, November, 2010:
 - (1) It could be a 'community day' to celebrate the Early Years and the good things that are happening
 - (2) We could have a format in which a business who supports the EY could speak (ie Ken from Times) as well as a parent who has benefited from a program
 - (3) A 'gala' with a silent auction etc. with presentations from people who have been served.
- iv. It was decided that in light of time to plan, for 2010, we will have a similar format as 2009 but will have a business speaker and a parent speaker.
 - (1) Could have a pamphlet with a tear off piece as to how they can contribute
 - (2) Could have a brain storming part where businesses can look at how they might contribute

v. It was noted that part of the Provincial mandate is to increase community support of the early years. Success by 6 will be one of the vehicles to achieve this.

ACTION: Sherry, Trish & Pauline will meet (others are welcome) to plan day

- g) CYC Early Years Community Coordinator Position discussion
 - i. Sherry brought info from a meeting held in June. Dan, Darby, Mary-Anne, Corrine McCabe, the SD Superintendent and Karin attended.

 - (1) Post the Community Coordinator contract at the end of August and hope to hire in September
 - (2) Darby will develop ad for newspapers and other websites.
 - (3) A three person interview panel of Dan, as MCFD Contract holder, Sherry, as co chair and one other core member. Kiran Sidhu's name was suggested.
